- The five top competitors in men's events will be awarded minimum cash prizes of:
**1st - \$50.00, 2nd - \$40.00, 3rd - \$30.00,
4th - \$20.00, 5th - \$10.00**
- The three top competitors in women's events will be awarded minimum cash prizes of:
1st - \$30.00, 2nd - \$20.00, 3rd - \$10.00

ENTRY FEES:

\$5.00 per event OR \$25.00 maximum

Important: Anybody who hasn't already paid must pay their \$10 MLA membership before competing.

Note: Entry deadline is August 31, 2011. Be sure to register for all the events you want! Ensure your partner has also registered.

In the interest of ordering wood, it would be best if you could EMAIL ME your registration. If I don't have an email, phone call or something confirming me that you will be attending before August 31th there will be a \$50 entry fee.

NO EXCEPTIONS.

IF you don't confirm with me before August 31th, there is no guarantee you will have chopping wood, or sawing wood, and there is a chance you will not be able to compete. If you do confirm you are coming before the date and don't show up, you will still be asked to pay the \$25 before you can compete at next years show.

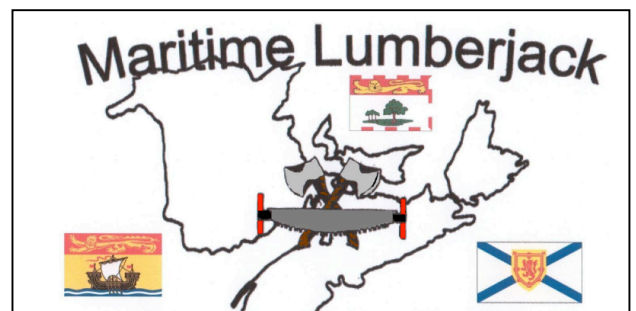
